**Four age categories:** – candidate registration within one age category will be done based on the age this has at **January 1st 2020**.

-A Category under 10 years old – recording a video of a program of maximum 10 minutes (free to choose one or more contrasting works belonging to repertories preclasic, clasic, romantic)

-B Category between 10-15 years old - recording a video of a program of maximum 15 minutes – free to choose two contrasting works in terms of style, form, genre, character (repertories preclasic, clasic, romantic, modern)

-C Category between 15-18 years old - recording a video of a program of maximum 20 minutes – free to choose two different works in style, form, genre, character (repertories preclasic, clasic, romantic, modern)

-D Category between 18-27 - recording a video of a program of maximum 30 minutes – free to choose two different works in style, form, genre, character (repertories preclasic, clasic, romantic, modern)

#### **IMPORTANT:**

Judging will be done based on age groups. Judges decisions will be unique and definitive.

The repertoire will be interpreted entirely by memory.

Competitors will have the possibility to present within the contest, recordings of the acompanied or solo works.

It's forbidden to use a video presented in another contest.
